Project Description

The California Department of Transportation (Caltrans) issued a District Director's Order to replace a failed sewer lateral on State Route (SR) 32 near postmile 9.14, in Butte County. A crushed sewer lateral was reported at 630 W 9th Street in Chico. Damage assessment concluded that a section of the existing 4-inch clay sewer lateral was removed during a placement of drain inlet (DI) in a recent Caltrans contract. This problem must be arrested as soon as possible in order to avoid the failure of travel way. This project is needed to avoid failure or threat of failure to the transportation system, which can result in the loss or impairment of life, health, or property.

Description (Continued from page 1)

The proposed solution is placing new lateral from the location where it crosses the sidewalk at the residence to where the broken lateral was found on the west side of the drain inlet. From there to the main sewer line would be trenchless following existing alignment.

The scope of work includes site preparation, traffic control, sewer outfall pipe replacement, and all associated work.

Right-of-Way

Staging and work occurred within Caltrans right-of-way.

No disposal that required a borrow site.
