Project Description

Caltrans District 1 proposes to correct the slide and culvert failure that occurred on SR-175 Post Mile (P.M.) 0.3. On December 26,2021 a large storm front impacted Lake County bringing heavy precipitation and snowfall. The storm caused slope saturation causing a large slip-out to develop below the roadway, resulting in separation of the culvert downdrain, further exacerbating the erosion and threatening the roadway.
