A new approximately 21,000 linear-foot, 48-inch diameter underground trunk line would the replace the existing Roscoe Trunk Line, entirely within Roscoe Boulevard between Mason Avenue and Louise Avenue. A new 18,000 linear-foot, 16-inch diameter mainline would be installed within Roscoe Boulevard from near Louise Avenue to Penfield Avenue. Two regulating stations would be installed. Approximately 2,300 linear feet of 12-inch diameter distribution mainline would also be installed within Reseda Boulevard, from Roscoe Boulevard to south of Bryant Street.
