A Conditional Use Permit to establish a 71,008 sq. ft., three-story storage facility, including a managers office, with Variances to permit an increase in building height from 35 feet to 43 feet 2 inches, an increase in the floor area ratio from 0.5 to 1.2, and reduction in the front yard setback from 15 feet to five feet on approximately 1.47 acres.
