**Project Description**

The California Department of Transportation (Caltrans) issued a District Director's Order to replace a failed culvert on State Route 99 near postmile 1.36, in Sacramento County. A failed culvert (system # 240994000118, end treatment 012-011) is reported on State Route 99 northbound off-ramp to Simmerhorn Road. Damage assessment concluded the existing elliptical corrugated steel pipe (1.5-ft by 2.4-ft) is separated near the middle with base rock inside the pipe. This problem must be arrested as soon as possible in order to avoid the failure of travel way. This project was needed to avoid failure or threat of failure to the transportation system, which can result in the loss or impairment of life, health, or property.
