Project Description:

Bluebird Canyon Fuel Modification Project and Park Avenue Fuel Modification Project would reduce vegetation in 100-foot zones in fuel modification zones (FMZs) 17 and 18 for approximately 17.8 acres across about 1.6 linear miles and 50-foot zones on either side of Park Avenue in FMZ 22 for a total of approximately 7.2 acres. Fuel management would reduce fire line intensity, reduce wildfire rates of spread, and improve occupant safety. To minimize erosion in erosion-prone areas, the majority of perennial root systems would remain, and post-treatment erosion control measures (e.g., scattered cut brush clippings, jute netting, straw wattles, etc.) would be applied.
