The Project proposes to develop 23 residential 4-plex buildings with a total of 92 3-bedroom townhomes on 9 acres (10.2 units/gross acre). The Project includes an internal recreation center, landscaped areas throughout for passive and active recreation, and 289 parking spaces will be provided. COMU GP designation and zoning allow 15-25 units/acre.
