WHEREAS, the Board of Directors of the Southgate Recreation & Park District proposes the renovation and related improvements at Crofoot Park, Bowling Green Park, Rainbow Park, Sky Park, and Sheldon Park and Florin Creek Trail; and

WHEREAS, the project are independent of each other and consist of the renovation and related site improvements; and

WHEREAS, the projects will provide new playground equipment, tennis courts, sports lights, art, court rebuild and resurfacing, adult exercise equipment, fencing, ADA pathways and trails, dog park, shade structures and site improvements for the benefit of the community and users of Crofoot Park, Bowling Green Park, Rainbow Park, Sky Park, and Sheldon Park; and

WHEREAS, the projects have been reviewed by the District's environmental coordinator and has been found to have no potential to cause a significant effect on the environment, and therefore categorically exempt under the California Environmental Quality Act (CEQA) guidelines as described in Section 15301 Existing Facilities, Section 15302 Replacement or Reconstruction, Section 15303 New Construction and Section 15304 Minor Alterations to Land; and

WHEREAS, a Notice of Exemption for each site has been prepared pursuant to CEQA Section 15062, to be filed with the appropriate State and County agencies.
