Project Description

The California Department of Transportation (Caltrans) proposes improving the crosswalk markings, delineation, and signage at each crosswalk location within four (4) different project limits. The work will occur in Merced County on State Route (SR) 152, from post mile 18.88 to 22.25; in San Joaquin County on SR-4, from post mile 15.80 to 15.87; in San Joaquin County on SR-12, from post mile 15.36 to 17.70; and in Stanislaus County on SR-108, from post mile 23.44 to 32.45. The scope of work will include selective grinding to remove the existing crosswalk markings and replacing them with Ladder-type delineation. New warning signs will be installed for pedestrian crossings on new signposts. All work will occur in existing Caltrans Right of Way. The purpose of this project is to warn motorists of crossing pedestrians and vehicles stopped at these intersections. The project is needed to reduce the number and severity of traffic collisions near these intersections.

General:

Cultural:

 3. Notify the Engineer
 4. The Department Investigates. Do not move cultural materials or take them from the job site. Retain a qualified archaeologist to assess the significance of the find. Do not resume work within the discovery area until authorized.
- If human remains are discovered, State Health and Safety Code Section 7050.5 states that further disturbances and activities shall cease in any area or nearby area suspected to overlie remains, and the County coroner contacted. Pursuant to Public Resources Code Section 5097.98. If the remains are thought to be Native American, the coroner will notify the Native American Heritage Commission (NAHC) who will then notify the Most Likely Descendent (MLD). At the same time the landowner will work with the MLD on the respectful treatment and disposition of the remains. Further provisions of PRC 5097.98 are to be followed as applicable.

Hazardous Waste:

- Caltrans Standard Special Provision 7-1.02K(6)(j)(iii) pertaining to earth material containing lead, shall be included in the contract.
