The San Francisco Municipal Transportation Agency (SFMTA) proposes transportation and safety improvements along the above-noted corridors to increase pedestrian and bicyclist visibility and safety. The project would extend an existing two-way bikeway along the eastern side of The Embarcadero, north from Mission to Broadway, and south from Folsom to Bryant. The project would also implement one-way bike lanes in each direction on Washington Street. To accommodate these improvements, the project would remove a northbound lane on The Embarcadero between Mission and Broadway and would also remove a travel lane in each direction on Washington between The Embarcadero and Drumm.
