**Project Description**

The California Department of Transportation (Caltrans) issued a Director's Order to repair damaged culverts and slope on State Route (SR) 49. Two damaged culverts were reported near postmile 4.9 on northbound SR 49, in Yuba County. Both culverts are under the access road for the property located at 16271 CA-49, Camptonville CA 95922. Damage assessment concluded that both the 12-inch and 24-inch (System # 160494000507 002-001) corrugated metal pipes are damaged due to bank erosion. This problem must be arrested as soon as possible in order to avoid the failure of travel way. This project was needed to avoid failure or threat of failure to the transportation system, which can result in the loss or impairment of life, health, or property. (Continued on page 3)

#### **Right-of-Way**

All staging and work occurred within Caltrans right-of-way.

There was not disposal requiring a borrow site.

#### **Consultation/Coordination**

Based on the scope of work and due to the nature of the project, consultation or coordination was not required.

#### **Permits**

A 1610 Lake and Streambed Alteration Notification from the CDFW was required for the temporary work within an ephemeral drainage and installed additions of soil stabilization material.
