King City Capital Preventative Maintenance Project on U.S. 101 in Monterey County

WHAT IS BEING PLANNED?

to improve the highway pavement and make additional highway facility improvements on an 8-mile stretch of U.S. 101 near King City, between Jolon Road and Lagomarsino Avenue, in Monterey County. The project would include Preventative Maintenance strategies to maintain the roadbed and improve ride quality as part of the 2020 State Highway Operations and Protection Program (SHOPP). The improvements include replacing pavement, replacing culverts, adding streetlights, and replacing a weigh-in

motion station and traffic census stations.

Caltrans has studied the effects this project may have on the environment. Our studies show it will not significantly affect the quality of the environment. This notice also offers you the opportunity to request a public hearing.


WHERE YOU COME IN?
