Project Description

The California Department of Transportation (Caltrans) issued a District Director's Order to repair damage to a rock wall barrier and a drainage system in Lake County on State Route (SR) 20 between post mile (PM) 26.9 to PM 27.6. Damage of the arched stone barricade wall along SR 20 must be repaired to ensure the safety and security of the traveling public. A drainage system beneath the rock wall has been identified as being in poor condition and is also scoped for replacement. Given the condition of the arched stone barricade wall and drainage system, it is necessary to perform the repairs immediately. The project is needed to prevent or lessen the loss or impairment of life, health, property and essential services.
