Project Title: El Capitan Dam Spillway

Project Description: The San Diego Water Board issued a Clean Water Act section 401 water quality certification (Certification No. R9-2023-0121) to the Project proposes to remove accumulated vegetation and debris from the El Capitan dam spillway to allow for unimpeded spillway flow as mandated by the Division of Safety of Dams (DSOD). Approximately 58,900 cubic yards of debris and 5.1 acres of vegetation are estimated to be removed from the overall 9.8-acre project site for the Discharger to comply with this mandate.

This is to advise that the San Diego Water Board, a Responsible Agency, has approved the above-described project on August 2, 2023 and has made the following determinations regarding the above-described project.

1. The project will/will not have a significant effect on the environment.
2. A Negative Declaration was prepared for this project pursuant to the provisions of CEQA.
3. Mitigation measures were made a condition of the San Diego Water Board's approval of the project.
4. A mitigation reporting or monitoring plan was adopted by the San Diego Water Board for this project.

5. A statement of Overriding Considerations was not adopted by the San Diego Water Board for this project.
6. Findings were not made by the San Diego Water Board pursuant to the provisions of CEQA.
