NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

For County Clerk's Stamp

Notice is hereby given that the County of Fresno has prepared Initial Study Application (IS) No. 8198 pursuant to the requirements of the California Environmental Quality Act for the following proposed project:

INITIAL STUDY APPLICATION NO. 8198 and **CLASSIFIED CUP APPLICATION NO. 8198** filed by **SAC Wireless**, proposing to Allow a wireless telecommunications facility on a 1.91-acre parcel in the AL-20 (Limited Agricultural, 20-acre minimum parcel size) Zone District. The project site is located directly east of the intersection of S. Fowler Avenue and E. Erin Avenue and is adjacent to the City of Fresno (APN: 316-160-41S) (1038 S. Fowler Avenue) (Sup Dist. 4). Adopt the Mitigated Negative Declaration prepared for Initial Study Application No. 8198 and take action on Unclassified CUP Application No. 8198 with Findings and Conditions.

(hereafter, the "Proposed Project")

The County of Fresno has determined that it is appropriate to adopt a Mitigated Negative Declaration for the Proposed Project. The purpose of this Notice is to (1) provide notice of the availability of IS Application No. 8198 and the draft Mitigated Negative Declaration and request written comments thereon; and (2) provide notice of the public hearing regarding the Proposed Project.


