The project is an application for a Conditional Use Permit to allow construction of a 700-megawatt (MW) battery energy storage system (BESS) facility over a contiguous 42-acre parcel, subject to the provisions of the County Zoning Ordinance (Title 17, Section 17.54.130). The project would take place over two phases. Phase 1 would include a 400 MW BESS on approximately 30 acres, and an anticipated second phase would add an additional 300 MW on 12 acres. The proposed project would consist of a 230-kilovolt overhead gen-tie line that would extend to the PG&E Tesla Substation. Additionally, other components of the project include an onsite switchyard, inverters, fencing, a driveway/access road from Midway Road, internal maintenance roads, sound walls, a supervisory control and data acquisition system, and other ancillary facilities or equipment.
