NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION MONTEREY COUNTY PLANNING COMMISSION

NOTICE IS HEREBY GIVEN that Monterey County Housing & Community Development (HCD) has prepared a draft Mitigated Negative Declaration, pursuant to the requirements of the California Environmental Quality Act (CEQA), for a Combined Development Permit (Love, File Number PLN210007) at 30560 Aurora Del Mar, Carmel, Big Sur Coast Land Use Plan, Coastal Zone (Assessor's Parcel Number 243-331-003-000) (see project description below).

The Mitigated Negative Declaration and Initial Study, as well as referenced documents, are available for review at Monterey County HCD-Planning, 1441 Schilling Place South 2nd Floor, Salinas, California, 93901. The Monterey County Planning Commission will consider this proposal at a public hearing on a future date to be determined, in the Monterey County Board of Supervisors Chambers, 168 West Alisal, 2nd Floor, Salinas, California. Written comments on this Mitigated Negative Declaration will be accepted from May 9, 2022 to June 8, 2022. Comments can also be made during the public hearing.

Project Description: Combined Development Permit consisting of a Coastal Administrative Permit and Design Approval to allow the construction of a 5,067 square foot two-story single-family dwelling with a 782 square foot attached garage; a Coastal Administrative Permit and Design Approval to allow construction of a 425 square foot detached guesthouse; a Coastal Development Permit to allow development within 750 feet of known archaeological resources; a Coastal Development Permit to allow development within 100 feet of an environmentally sensitive habitat area; a Coastal Development Permit to allow development on slopes exceeding 30 percent; and a Coastal Development Permit to allow development within 50 feet of a coastal bluff.

We welcome your comments during the 30-day public review period. You may submit your comments in hard copy to the name and address below. HCD-Planning also accepts comments via e-mail or facsimile but requests that you follow these instructions to ensure that HCD-Planning has received your comments.
