PROJECT DESCRIPTION: The State Water Resources Control Board (State Water Board) is a Responsible Agency for the Project. The Applicant has applied for financial assistance from the State Water Board's Drinking Water State Revolving Fund (SRF) Program for the Project referred to internally as City of Orange Wells 20, 21 and 22 PFAS Treatment Systems. The Project includes the installation of per- and polyfluoroalkyl substances treatment systems at three existing well sites (Well 20, Well 21, and Well 22). Each treatment system would include a new ion exchange vessel system, necessary piping and related appurtenance.

PUBLIC AGENCY APPROVING PROJECT AND CARRYING OUT PROJECT:
