Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement EPIMS-STA-32599-R4, pursuant to Fish and Game Code section 1602, to the project Applicant, Stanislaus County.

The Project involves activities related to the demolition of the existing Milton Road bridge over Hoods Creek (Bridge No. 38C0232) and replacement with a two-lane bridge structure to provide improved safety and operations.
