The project site is an approximately 2.5-acre portion of a 34.76-acre parcel, The surrounding area consists primarily of agricultural operations and agricultural support operations with sparse residential development intermixed with some limited commercial development.

Staff provided notices to the Picayune Rancheria of the Chukchansi Indians, Table Mountain Rancheria, Dumna Wo Wah, and Santa Rosa Rancheria Tachi Yokut tribes. None of the Native American Tribes expressed any concerns with or requested consultation on this project.

NOTE: Conducting consultation early in the CEQA process allows tribal governments, lead agencies, and project proponents to discuss the level of environmental review, identify and address potential adverse impacts to tribal cultural resources, and reduce the potential for delay and conflict in the environmental review process.
