Description of Nature, Purpose and Beneficiaries of Project:

This project's anchor asset is pavement, plus rehabilitation of satellite assets. Satellite asset improvements include the following: drainage system restorations; shoulder backing, asphalt concrete (AC) dike replacement; Transportation Management System (TMS) element upgrades; traffic count loops at all ramps; roadside safety improvements; upgrading median concrete barrier and guardrail to MASH standards; bridge rail upgrades and bridge seismic restorations on the North and South State Street Bridge Overcrossings; sign panel replacements; shoulder mumble strips; curb ramp upgrades; and trash capture installations or modifications. Approximately 20 acres of roadside rehabilitation will be implemented as a landscape split-off project. The project would occur mostly within the operational right of way, with one temporary construction easement needed for culvert work at PM 16.5.
