The California Department of Transportation (Caltrans) issued a District Director's Order (DDO) and Supplemental DDO to complete the remaining work under terminated contract EA 03-4F640 at multiple locations on State Routes 80 and 99 in Sacramento County. There are approximately 20 incomplete locations with temporary traffic handling devices in place for over a year. Some of these traffic handling devices have been hit and damaged. The project was needed to avoid the failure or threat of failure to the transportation system and to prevent or lessen the loss or impairment of life, health, property, and essential public services.
