Project Title: Streambed Alteration Agreement No. 1600-2022-0004-R1 for Timber Harvesting Plan (THP) 1-22-00006-MEN

Project Location: The activities to be completed according to the Agreement are located 5 miles southwest of Willits, in Mendocino County, in Baechtel Creek, tributary to the Eel River, unnamed tributaries to North Fork Martin Creek, tributary to the Big River, and unnamed tributaries to the Eel River and Big River. The project is located in Sections 5 and 9, Township (T) 17N, Range (R) 14W; Section 32, T18N, R14W; Mt. Diablo Base and Meridian, in the Greenough Ridge, California, U.S. Geological Survey 7.5-minute quadrangle.

Project Description: The Department of Fish and Wildlife (CDFW) is issuing an agreement for modify Class I, Class II, and Class III watercourses at new and existing road crossings, and water diversion from a Class II spring.

This is to advise that CDFW, acting as  the Lead Agency /  a Responsible Agency approved the above-described project and has made the following determinations:
