WHAT'S BEING PLANNED:

The California Department of Transportation (Caltrans), in cooperation with the Alameda County Transportation Commission (Alameda CTC) and the City of Hayward (City), proposes to provide interchange and local road improvements along Interstate 880 (I-880) from 0.1 mile north of the I-880/A Street Interchange to 0.4 mile south of the I-880/Winton Avenue Interchange. The I-880 Interchange Improvements Project (Project) would include interchange on-and-off-ramp reconfigurations, local roadway restriping, and bicycle and pedestrian improvements in the City of Hayward, in Alameda County, California.

WHY THIS NOTICE:

Caltrans, as the California Environmental Quality Act (CEQA) and National Environmental Policy Act (NEPA) lead agency, has studied the potential effects that the proposed improvements may have on the environment. The results of these studies are summarized in an Initial Study (IS) with Proposed Negative Declaration, also referred to as the Draft Environmental Document (DED). This project is subject to and complies with the requirements of both the CEQA and NEPA. The purpose of this notice is to inform the public of the availability of the DED, to provide the public an opportunity to review and comment, and to notify the public of a virtual public meeting and an opportunity for a question and answer (Q&A) session.
