§ 15304. Minor Alterations to Land. No grading will be taking place and no healthy plants will be removed from the environment. New landscaping with native, local plants will be installed. § 15321. Enforcement Actions by Regulatory Agencies. Remediation at the site is in response to an NOV issued by CDFW which requires the site to be cleaned up. § 15330. Minor Actions to Address Hazardous Substance. Part of the required cleanup is the collection and proper disposal of hazardous materials including pesticides, nutrients, and fertilizers. § 15333. Small Habitat Restoration Projects. The clean up and revegetation of the project site will help return the on-site habitat to its former state prior to the illicit cultivation.


