

If there are no major comments or requests for a hearing, Caltrans will proceed with the project's design.



### WHAT IS BEING PLANNED?

The California Department of Transportation (Caltrans) proposes to install or rehabilitate existing culverts and storm drains in various locations on State Routes 26 and 12 in Calaveras County and State Routes 108 and 120 in Tuolumne County.

### WHY THIS PUBLIC NOTICE?

Caltrans has studied the effects this project may have on the environment. Our studies show the project will not significantly affect the quality of the environment. The report that explains why is called an Initial Study with Proposed Mitigated Negative Declaration. This notice is to inform you of the preparation of the Initial Study with Proposed Mitigated Negative Declaration and of its availability for you to read and comment on. This notice also offers you an opportunity to request a virtual public meeting.
