



Do you want a virtual public hearing on changes proposed for State Route 166 in Kern County?



PUBLIC COMMENT PERIOD

Comments will be accepted from March xx, 2022 to March xx, 2022. If there are no major comments or requests for a hearing, Caltrans will proceed with the project's design.

WHAT IS BEING PLANNED?

The California Department of Transportation (Caltrans) proposes to repair 26 culverts and rehabilitate State Route 166 just east of the City of Maricopa between post mile 0.00 and post mile 10.2 in Kern County. Replacing or repairing the pavement structural section and deteriorating drainage systems is necessary to maintain the operational integrity of State Route 166.

WHY THIS PUBLIC NOTICE? Caltrans has studied the effects this project may have on the environment. Our studies show the project will not significantly affect the quality of the environment. The report that explains why is called an Initial Study with Proposed Mitigated Negative Declaration.
