

Notice of Intent to Adopt a Mitigated Negative Declaration

State Route 74 Lake Elsinore Median Buffer and Widen Shoulders



<p>WHAT'S BEING PLANNED</p>	<p>The California Department of Transportation (Caltrans) proposes to provide two feet wide median buffer and four feet wide outside shoulders including median and shoulder rumble strips on the two-lane conventional highway. State Route 74 (SR-74), also known as Ortega Highway is located in the County of Riverside, near the city of Lake Elsinore from Monte Vista Street to Grand Avenue (Postmile 5.7 to 11.8).</p>
<p>WHY THIS AD?</p>	<p>Caltrans has studied the effects this project may have on the environment. Our studies show it will not significantly affect the quality of the environment. The report that explains why is called an <i>Initial Study (with Proposed Mitigated Negative Declaration)</i>. This notice is to tell you of the preparation of the <i>Initial Study (with Proposed Mitigated Negative Declaration)</i> and of its availability for you to read, and to also offer the opportunity to request a public hearing or to provide comments, and the intent to adopt this Mitigated Negative Declaration.</p>
