A double -sided Outdoor Display Sign, also known as a digital billboard would be constructed at 400 E. Millbrae Ave. The back-to-back LED displays would face north and south along US-101 northbound on a parcel owned by the Ctiy, on the site of the City's Water Pollution Control Plant (WPCP). The sign would be 45 feet high and its frame would be 14' high by 48' wide. The sign would operate 24 hours a day, seven days a week, primarily used for commercial advertisement.
