Description of Nature, Purpose, and Beneficiaries of Project:
The City of Redding proposes to repair the Sacramento River Trail at a total of twenty-six work sites. The ordinary high-water mark (OHWM) of the Sacramento River intersects the work area at 4 locations. The project will repair seating and viewing areas, trail surfaces, trail embankments, and trail shoulders. Work will include vegetation removal, demolition, excavation, grading, sediment removal, culvert cleaning, paving, concrete repair, bench replacement, placement of rock slope protection, vegetation planting, and hydro-seed application.
