The California Department of Transportation (Caltrans), using state funding only, is proposing to restore the roadway to a condition that requires minimal maintenance. The project will mill off then apply a 0.10' overlay of Hot Mix Asphalt (HMA) over approximately 2 miles of SR 273 in Shasta County (PM 12.8/14.6).



All work will be confined within the existing roadbed hinge point. Removal of thermoplastic pavement markings and cold planing of existing surface will be required to match existing features. No work will be performed on bridge decks, guardrails, or drainage inlets.

Purpose: The purpose of the project is to provide efficient, easily maintained pavement that provides minimum maintenance for multiple years, as well as increase safety for travelers and workers.

Need: The existing roadway is in a poor condition with localized areas of severe distress. Routine maintenance has not been sufficient to maintain an adequate road surface.

Right-of-Way

Acquisitions or TCEs will not be needed for this project due to work being confined to the ROW.

Staging/Stockpiling

Multiple locations are available for staging/stockpiling use. No grading and/or site preparation will occur. Approved staging locations include: PM 12.45 SB, PM 14.2-14.3 NB.

Disposal/Borrow Sites

The project would not utilize borrowed material. If any excess material is generated, it will be a small enough quantity to become property of the contractor.

Coordination/Consultation

Based on the scope of the project, no outside coordination or consultation was carried out/required.

Permits

No permits are necessary with current scope of work.

Utilities

All utilities in proximity to the locations of work would be protected in place; no utility conflicts are anticipated.
