Project Description

The Project entails the rehabilitation, within the existing alignment, of sanitary sewer mains and related appurtenances located within the Town of San Anselmo, which are in need of imminent repair. The Modified Project area encompasses approximately 0.04 acres. Approximately 1,922 linear ft of existing 6-in. VCP would be replaced 8-in. HDPE pipe via pipe bursting methods.

Amendments to the IS/MND include the addition of a sewer line segment in the Town of San Anselmo in need of imminent repair. Amendments do not significantly alter the findings of the IS/MND or require major revisions.
