This Notice of Exemption is filed on June 29, 2022.

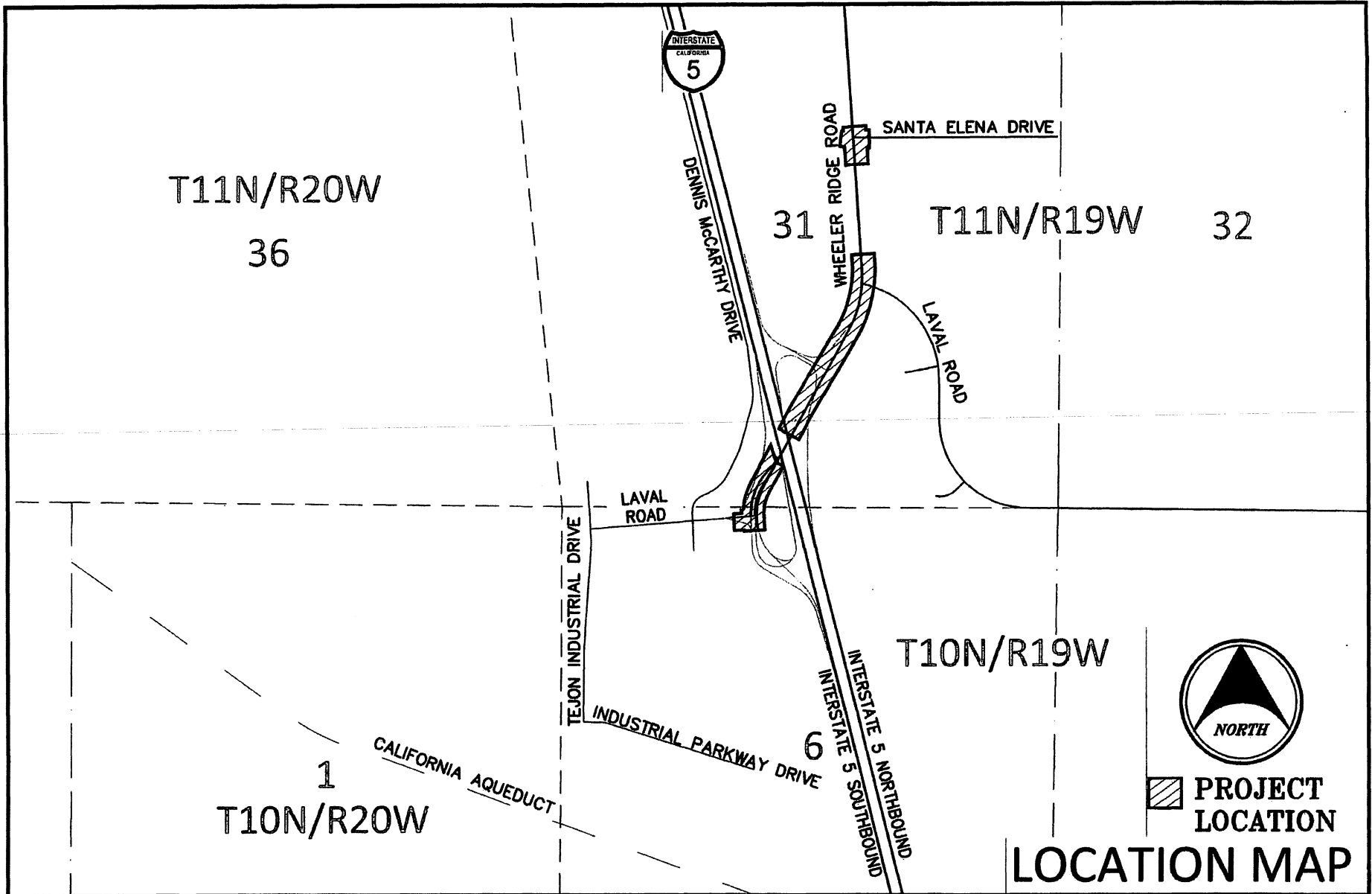
