Allow the creation of four (4) parcels, three 5.01-acre parcels and one 5.03-acre parcel, from one (1) existing 23-acre parcel.

The subject parcels are located in an area of agricultural grazing land and mixed residential land uses. Millerton Lake is adjacent to the western boundary the northern boundary of the parcel(s).

11. **Have California Native American tribes traditionally and culturally affiliated with the project area requested consultation pursuant to Public Resources Code section 21080.3.1? Per Assembly Bill 52 (AB52), participating California Native American Tribes were notified of the project and given the opportunity to enter into consultation with the County regarding the proposal.

On December 28, 2021, the following tribes were notified of the proposed project: Picayune Rancheria of the Chukchansi Indians, Dumna Wo Wah Tribal Government, Table Mountain Rancheria, Santa Rosa Rancheria Tachi Yokut Tribe. Of the notified tribes Table Mountain Rancheria responded with a letter indicating interest in the project and requesting consultation. A records search conducted by the Southern San Joaquin Valley Information Center was provided to Table Mountain Rancheria (TMR) representatives, followed by an onsite visit on June 10, 2022. Following the onsite visit, it was determined that no cultural resources were present or at risk of being disturbed by the proposed project. TMR representatives indicated via an email to the County on June 10, 2022, that the consultation was completed pursuant to AB52

NOTE: Conducting consultation early in the CEQA process allows tribal governments, lead agencies, and project proponents to discuss the level of environmental review, identify and address potential adverse impacts to tribal cultural resources, and reduce the potential for delay and conflict in the environmental review process. 

I. AESTHETICS
