

**NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION**

Pursuant to Title 14 of the California Code of Regulations, Sections 15072 and 15073, this is to advise that the City of Highland, which is the lead agency overseeing this project, has completed a Mitigated Negative Declaration for the proposed project described below.

**PROJECT TITLE & FILE No.:** NWC of 3rd Street and Central Avenue Warehouse Project

**PROJECT LOCATION:** Northwestern corner of 3rd Street and Central Avenue, Highland, CA (APNs: 1192-561-11, 1192-561-15, 1192-561-16, 1192-561-17, 1192-561-18, 1192-561-19, 1192-561-20, and 1192-561-21)

**PROJECT DESCRIPTION:** The project includes demolition of one existing structure and construction of an approximately 54,330-square-foot (gross area, inclusive of mezzanine/office spaces), one-story warehouse building on an approximately 3.01-acre site (gross area). The warehouse building would be composed of approximately 48,330 square feet of warehouse space and 6,000 square feet of mezzanine/office space. The project site is not any list of hazardous waste sites prepared pursuant to Government Code Section 65962.2.

**PUBLIC REVIEW PERIOD:** The Mitigative Negative Declaration is available for public review and comment pursuant to California Code of Regulations, Title 14, Sections 15072 and 15073 (California Environmental Quality Act). Your comments may be sent as soon as possible, but no later than **5:00 p.m., August 1, 2022**. All comments must be submitted in writing to the address below.
