The proposed project would include the development of a portion of the project site with a 180-foot-tall radio communications tower, a 12-foot by 16-foot shelter, a 60-kiloWatt emergency generator, and 500-gallon propane tank. An access driveway would be provided from the parking lot of the adjacent property to the east. Ground disturbing activities associated with construction of the proposed project would be limited to establishing the tower foundation, assembly of the tower and shelter, and worker vehicle circulation.
