Description of nature and purpose of the Project: The project proposes a Coastal Development Permit (CDP) for the remodel of an existing one-level, single-family residence, addition of 761 square-foot (sf) to the first level, addition of new 1,183 sf, second-story, and roof deck, on a 0.16-acre site. The existing detached garage with guest quarters would remain. The project is in the RS-1-7 (Residential-Single Unit) zone, of the Peninsula Community Plan, Coastal Overlay Zone (Non-Appealable 2), Coastal Height Limit Overlay Zone, Transit Priority Area, Parking Impact Overlay Zone (Coastal Impact), Airport Influence Area (San Diego International Airport (SDIA), Review Area 2), and the Federal Aviation Administration (FAA) Part 77 Notification area (SDIA and North Island Naval Air Station). The community plan designates the site as single family residential with maximum density of 9 dwelling units per acre.

Reasons why project is exempt: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment. The project meets the criteria set forth in CEQA Section 15303 which consists of construction and location of limited numbers of new small facilities or structures. Since CEQA Section 15303 allows for the construction and location of limited number of new structures, this exemption was deemed appropriate for this project. This exemption includes but is not limited to: one single family residence or a second dwelling unit in a residential zone. In addition, the exceptions listed in CEQA Section 15300.2 would not apply.


