Camarena Health proposes to develop a two story Medical-Dental Office Building with a combined 16,600 square feet on a 1.94-acre site generally located along the north side of Pacheco Boulevard just east of Ward Road and Legacy Construction proposes to construct a 12 pump Gasoline/Service Station with Convenience Market and approximately 100,073 square feet of Mini-storage on a combined 6.43 acres. Within the Convenience Market building, 1,280 square feet Fast Food with drive-thru Window will be included. The projects will also include associated site improvements.
