Project Title: Streambed Alteration Agreement EPIMS Notification No. PLU-30938-R2, "Icky Thump" Timber Harvesting Plan 2-15-018-PLU, Applied Forest Products/Chy Company

Project Location: The project is located within the boundaries of a timber harvesting plan in Gansner Creek, tributary to Spanish Creek thence the Feather River, Plumas County. Township 24N, Range 9E, Section 22, Quincy USGS Quad map, Mount Diablo Base and Meridian.

Project Description: The project is limited to the use of one existing water drafting site for the purposes of dust abatement, road maintenance and fire suppression for timber salvage operation. More information can be found in THP No. 2-15-018-PLU.
