Project Title: EMERGENCY PERMIT FOR TREATMENT OF HAZARDOUS WASTE, KAISER PERMANENTE, RICHMOND, CALIFORNIA

Approval Action Under Consideration by DTSC: Emergency Permit

Statutory Authority: California Health and Safety Code, Chapter 6.5

Project Description: The California Department of Toxic Substances Control (DTSC), pursuant to authority granted under California Code of Regulations, Title 22, Division 4.5, Chapter 20, Section 66270.61, has issued an Emergency Permit to the Kaiser Permanente, (EPAID# CAL000366660) to treat hazardous waste through a controlled reaction with a chemical solution. Specifically, one (1) container of Diethyl Ether, must be stabilized prior to transport to an authorized hazardous waste treatment, storage, and disposal facility.

This chemical is currently being stored at Kaiser Permanente located at 914 Marina Way South, Richmond, CA 94804. DTSC has determined as a safety precaution to prevent an accident or severe injury, an Emergency Permit should be issued to chemically stabilize the hazardous waste prior to storage and eventual transportation off-site by Clean Harbors Environmental Services (CHES).

Background: The chemical noted above is peroxide forming material. The chemical produces peroxide compounds as it degrades (i.e., after the product's expiration date). The peroxide produced may be unstable at relatively low concentrations, resulting in fire and/or explosion if improperly managed. Static electricity or heating from sunlight may be enough to trigger a reaction, making transport of non-stabilized chemicals hazardous. Chemical stabilization is recommended prior to transport to a permitted treatment, storage, and disposal facility.

Project Activities: The treatment of the hazardous waste involves the addition of solution to the containers in a controlled manner to reduce the reactive or ignitable characteristics of the chemical. Treatment will take place within a designated exclusion zone. Only technicians from Clean Harbors

will be allowed in the exclusion zone. Movement, preparation, and treatment of the containers will be in accordance with established standards.

Within ten business days of the expiration of this permit, Kaiser Permanente will submit a final report, signed in accordance with Title 22, California Code of Regulations section 66270.11(d). The report shall include certification that the treatment area has been cleared of all residual hazardous waste generated from this emergency treatment and all generated waste has been responsibly managed.

The Emergency Permit is effective beginning July 22, 2022 and shall expire on September 19, 2022.

Reasons Why Project is Exempt: This action is necessary to prevent an emergency. Chemical stabilization of the chemicals is necessary prior to transportation to an authorized hazardous waste treatment, storage, and disposal facility to prevent accidental fire and/or explosion during transport.
