Project Title: Streambed Alteration Agreement No. 1600-2022-0004-R2 ("Pea Pod" Timber Harvesting Plan 2-22-00068-PLA, Sierra Pacific Industries)

Project Location: The projects are located within the boundaries of a timber harvesting plan in Placer County, within CALWATER watersheds Peavine Creek, Big Mosquito Creek and their connecting tributaries; Township 14N, Range 12E, Section 14 of the U.S. Geological Survey (USGS) 7.5-minute Quad Map Green Store, Mount Diablo Base and Meridian.

Project Description: The projects are limited to the construction of two in-channel waterholes, a rock ford and a vented rock ford. Further explanation of work can be referenced within the THP 2-22-00068-PLA.

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):
