This project is A Use Permit application to develop an existing 3-acre lot to include a 3,500 square foot convenience store, a 2,000 square foot restaurant with a drive-thru, a 5,775 square foot canopy with four (4) diesel gas dispensers for tractor trailers, a 3,300 square foot canopy with five (5) gas dispensers for automobiles, and parking for fifteen (15) tractor-trailers. The project proposes 14,575 square feet of total buildings at full buildout. The project site has access from the Interstate 5 and State Route 33 off ramps. The proposed project will utilize an onsite water well, septic system, and storm water drainage. The project site is not under a Williamson Act contract.
