Lift Station 13 is located in the Doheny State Beach parking area, approximately 650 feet southeast of the pedestrian overpass along Coast Highway and approximately 1,030 feet northwest of Beach Road and the Capistrano Beach parking lot. Lift Station 14 is located along Beach Road, approximately 25 feet southwest of the Amtrak railroad tracks and approximately 100 feet southwest of Coast Highway. Both sites are located in the City of Dana Point, California.

Description of Nature, Purpose and Beneficiaries of Project:

The proposed Lift Station 13 and 14 Ship Ladder Replacement Project (Project) involves replacing the existing ladders within Lift Station 13 and Lift Station 14. The Project would involve removing the existing ladders from the two lift stations and installing replacement stainless steel ship ladders and guardrails. Additional work would include installation of associated components and fittings to secure the new infrastructure to the existing Lift Station structures. All improvements would be located within the right-of-ways in the City. The Project improvements would provide continued reliability of the water conveyance system.
