Description of Nature, Purpose and Beneficiaries of Project:

The proposed Project is the replacement of approximately 60 to 80 feet of the water transmission main pipeline within the right-of way (ROW) at the intersection of Avenida Presidio and North La Esperanza in the City. The replacement pipe would be approximately 45 feet in length of 12-inch steel pipe, generally running east to west within the ROW of Avenida Presidio and approximately 40 feet of 24-inch steel pipe running generally north-south within the ROW of North La Esperanza. Additional work would include installation of valves, fittings, and associated components; pavement restoration on Avenida Presidio and North La Esperanza; and reinstalling the water service for the affected service area. The Project improvements would provide continued reliability of the water conveyance system.
