The project proposes to demolish the existing buildings and replace them with a new 2-story 37,118 sq ft gym/locker room building and a 2080 sq ft fitness/weight room building. Demolition activities would occur over a 1 month period. The new gym would include basketball courts, locker rooms, a wrestling room, team rooms, bathrooms, showers, concession stand, a classroom and storage rooms. The basketball courts would include interior public address systems for games, and exterior safety lighting. The fitness/weight building would be a single-story building connected to the gym building via a covered walkway. The maximum heights of the proposed buildings would be 48 feet.
