**NOTICE IS HEREBY GIVEN**, to responsible agencies, trustee agencies, interested parties and the general public, that the City of Calistoga has made available for public review a Draft Initial Study/Mitigated Negative Declaration (IS/MND) for the proposed Draft Housing Element 2023-2031 (Project).

The City of Calistoga will accept public comments on the Draft IS/MND during a 30-day public review period starting on Tuesday, August 23, 2022 and extending through September 21, 2022.

**PROJECT LOCATION:** Citywide. (6<sup>th</sup> Cycle Housing Sites: 011-062-009; 011-062-008; 011-072-020; 011-050-024; 011-101-002; 011-214-001; 011-214-002; 011-214-006; 011-215-001; 011-215-011).

**LAND USE/ ZONING:** Citywide (6<sup>th</sup> Cycle Housing Sites: Community Commercial (CC); High Density Residential (HDR); Light Industrial (LI))/ Community Commercial (CC); Multifamily Residential/Office (R3); Industrial (I))

**PROJECT DESCRIPTION:** The proposed project is a General Plan Amendment to update the City of Calistoga's Housing Element which consists of the following:

- Housing development constraints (including zoning allowances)
- Housing needs and fair housing
- At-risk housing
- Accommodating the Regional Housing Needs Allocation (RHNA) which includes identifying specific sites appropriate for affordable housing
- Updating existing & establishing new objectives, policies, and programs, and affirmatively furthering fair housing through site selection, public outreach, and the development of policies and programs.

**PUBLIC HEARING:** A Public Hearing on the Draft Housing Element and Draft IS/MND has not been scheduled. Once hearing date(s) have been determined, a public notice will be issued.
