The Project would develop 28.9 acres of the 37.55-acre site with two new light industrial warehouse buildings and related site improvements. The southeast 8.6-acres of the site would remain as open space. The Project includes construction and operation of approximately 648,630 square feet of new building space, including 125,648 square feet of refrigerated storage space, within the two proposed buildings. The Project would be implemented in one development phase. The Project Applicant is requesting a Development Plan Review and Tentative Parcel Map (TPM) to develop the Project.
