

Work will brush vegetation to clear roadway; remove current roadway base rock; construct two rock drainage lenses to improve drainage in roadway; add 6,800 linear feet of class 2 base rock and reshape and compact roadway; and replace four culverts to improve drainage on Año Nuevo Reserve located in San Mateo County, California.
