DESCRIPTION OF NATURE AND PURPOSE OF THE PROJECT: A Neighborhood Use Permit (NUP) to include a 26 foot-tall decorative pole to support a canister antenna with the tip of the antennas at 29 feet, four Remote Radio Units (RRUs) with associated wires and an underground vault for the equipment located within the Right-of-Way. The site is located at the corner of Broadway and Fourth Ave in the commercial zone of the Downtown Community plan area.

REASONS WHY PROJECT IS EXEMPT: The City of San Diego determined that the project would qualify to be categorically exempt from CEQA pursuant to Section 15303 (New Construction). Since the project would only construct one WCF on a previously developed site it was determined that the exemption was appropriate, and the exceptions listed in CEQA Section 15300.2 would not apply.


