Gallup Creek Bridge on Cooperstown Road Replacement Project Notice of Availability of Initial Study and Notice of Intent to Adopt a Mitigated Negative Declaration

WHAT IS BEING PLANNED?

Stanislaus County, in coordination with the California Department of Transportation, proposes to replace the Cooperstown Road over Gallup Creek Bridge, located approximately 3.8 miles northwest of La Grange. The existing bridge was built in 1965 and is in need of replacement for improved safety and to meet current road standards. Stanislaus County intends to replace the existing bridge with new two-span cast-in-place, concrete slab bridge with Type 85 concrete barrier railings. Construction of the new bridge is anticipated as early as 2024, if funding becomes available. The construction of the new bridge would take approximately eight months with access over the creek provided by an adjacent temporary detour. Signage and public outreach would inform the community of the closure and local detour.

WHY THIS PUBLIC NOTICE?

Stanislaus County has studied the effects this project may have on the environment. The studies within the Initial Study with Proposed Mitigated Negative Declaration show it would not significantly affect the quality of the environment. This notice is to advise you that the preparation of this report has been completed and is available for you to review.

WHAT'S AVAILABLE?

An Initial Study with Proposed Mitigated Negative Declaration has been prepared and is available for review beginning **Friday, September 2, 2022 through Monday, October 3, 2022**.
